SWALE REMINDER:

In our June 2020 Summer Newsletter, you were informed about the importance of maintaining and/ or cutting away to create scuppers. This swale maintenance is still your responsibility. Although a few of you have been diligent about this, most have not. This does create flooding in your neighborhoods.
